## Rules and Expectations (Follow 1-2-3 Disciplinary Procedures)

- Skate at your own risk.
- Outside food/drinks are not allowed (except for birthday cakes for booked parties).
- Backpacks are not allowed.
- Use appropriate language, no profanity or suggestive language.
- No PDA (public displays of affection).
- Respect all Skate Night Staff and volunteers.
- Dress code: Wear school-appropriate clothing.
- Stay off the tables, lower balcony wall, stairs and stage.
- Keep food and drink off the skate floor.
- Clean up after yourselves.
- Walk inside the Key Peninsula Civic Center.
- The skate floor is for skating only.
- Shoes must be worn at all times. Parents/Guardians are allowed on the skate floor with shoes to assist young or beginner skaters. We are not responsible for lost/stolen/damaged goods. Skate carefully, follow the flow of traffic and be mindful of other skaters.

## Zero Tolerance Rules(Follow zero tolerance procedures)

- No fighting.
- No intoxication.
- Bully-free zone.
- Minors must exit with a parent or guardian over the age of 18.
- Drug/alcohol/smoke/vape/weapon-free zone.

## Zero Tolerance Procedures

- **1st offense:** Asked to leave, suspended for one month.
- **2nd offense:** Asked to leave, suspended indefinitely.

## 1-2-3 Disciplinary Procedures

- **1st offense:** Warning.
- **2nd offense:** 5-minute break to review rules.
- **3rd offense:** Asked to leave for the night, suspended for one week.
